**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination"), is dated as of August 24, 2016 and made by **ARES CAPITAL CORPORATION**, a Maryland corporation, as Administrative Agent ("Grantee"), located at 245 Park Avenue, 44th Floor, New York, NY 10167 to **LAZER LITE COVERS, LLC**, a Florida limited liability company ("Grantor"), located at 2303 SE 17th Street, Suite 102, Ocala, Florida 34471.

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of March 9, 2015, made by the Grantor in favor of the Grantee (the "Security Agreement"; defined terms used herein without definition shall have the meanings assigned to them in the Security Agreement), a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on March 11, 2015, at Reel 005476 and Frame 0405;

WHEREAS, the Obligations under the Loan Agreement have been indefeasibly satisfied in full, the Grantee's obligation to make Credit Extensions under the Loan Agreement have terminated, and Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
