ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the parties agree as follows:

1. ASSIGNOR hereby assigns to ASSIGNEE all right, title, and interest in and to the TRADEMARK, both registered and owned under common law, as well as the goodwill symbolized by the TRADEMARK and the business associated therewith, along with the right to sue for past, present or future infringement or other causes of action related to the TRADEMARK, the right to recover damages and profits for past, present or future infringement or other causes of action related to the TRADEMARK, and all income and royalties hereafter due or payable to ASSIGNOR with respect to the TRADEMARK.
2. ASSIGNOR hereby represents and warrants that there are no pending lawsuits, liens or other encumbrances against the TRADEMARK.

3. ASSIGNOR hereby represents and warrants that at the time of execution and delivery of this Agreement that all information contained herein is correct, that ASSIGNOR exclusively owns all rights in the TRADEMARK without any encumbrances, that ASSIGNOR has no actual knowledge of any third party that might assert any rights in the TRADEMARK, and that ASSIGNOR has the full right and lawful authority to sell and convey the TRADEMARK in the manner set forth herein.

4. ASSIGNOR further represents that the TRADEMARK is in good order, has full force and effect, currently is in use, and is not subject to a third party challenge asserting that the TRADEMARK has been abandoned based on non-use or any other reason.

5. ASSIGNOR agrees to execute all instruments and documents and perform additional acts as are reasonably necessary to effect, evidence, record, and perfect the Assignment and recordation of the rights being assigned hereunder.

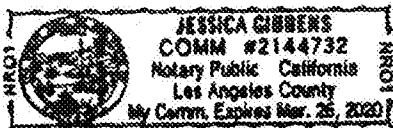
