RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated August 26, 2016, is made by and between **MENOMINEE ACQUISITION CORPORATION**, a Delaware corporation (“Debtor”), whose principal place of business and mailing address is 144 First Street, Menominee, Michigan 79858, and **FIFTH THIRD BANK**, an Ohio banking corporation, as Agent for the benefit of the Secured Creditors (as defined in the Credit Agreement) (“Agent”).
