TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement"), dated as of August 25, 2016 (the "Effective Date"), is made and entered into by and between Little Pros' Academy Holdings, Inc., a corporation existing under the laws of the State of Delaware with offices located at 3311 Carl Sandburg Court, Raleigh, NC 27610 ("Assignor") and REE Southeast, Inc., a corporation existing under the laws of the State of Delaware with offices located at 1732 Crooks Road, Troy, MI 48084 ("Assignee").

WHEREAS, Assignor is the owner of all right, title and interest in and to the trademarks and the registrations therefor listed in Schedule A attached hereto (the "Trademarks"); and

WHEREAS, Assignor desires to assign to Assignee, and Assignee wishes to acquire from Assignor, all of Assignor's rights in and to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:



Effective upon the Effective Date, Assignor assigns to Assignee, all of Assignor's rights, title and interest in and to the Trademarks, together with the goodwill of the business appurtenant to and symbolized by the Trademarks and including, without limitation, all common law rights in and to the Trademarks and the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Trademarks, to be held and enjoyed by Assignee, its successors and assigns to the same extent that such would have been held and enjoyed by Assignor had such assignment not been made.
2. This Agreement shall be binding upon, inure to the benefit of, and be enforceable by Assignor and Assignee and their respective successors and permitted assigns.
3. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.


