ASSIGNMENT

This ASSIGNMENT (this "*Assignment*") is made and entered into this 25<sup>th</sup> day of July 2016 by and between BOSC, INC., an Oklahoma Corporation (the "*Assignor*"), and BOK Financial Corporation, an Oklahoma corporation (the "*Assignee*"). NOW THEREFORE, for \$1.00 and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignment. Assignor hereby assigns to Assignee all of Assignor's right, title and interest in and to the Trademarks and any and all goodwill of the business symbolized by the Trademarks, including all rights therein provided by international conventions and treaties, and the right to sue for past, present and future infringement thereof, as fully and effectually as they would have been held by Assignor had this Assignment not been made.

2. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Oklahoma (regardless of the laws that might otherwise govern under applicable Oklahoma conflict of laws principles).

3. Further Assurances. Assignor shall, at the cost and expense of Assignee, take all actions and execute all documents necessary or desirable to record and perfect the interest of Assignee in and to the Trademarks, and shall not enter into any agreement in conflict with this Assignment.
