**DECLARATION**

I, Mary Denise Kuprionis, in accordance with TMEP §503.06(c), declare that:

1. I am Vice President & Secretary of The Boulder Publishing Company, LLC and have been an officer of this entity since its formation on June 21, 1999;
2. I am making this declaration with the knowledge and belief that another party caused an improperly executed assignment to be recorded at reel and frame 3417/0850 on October 30, 2006 against U.S. Trademark Registration No. 1,969,849, for DAILY CAMERA & Design;
3. The true and correct chain of title for U.S. Trademark Registration No. 1,969,849 for DAILY CAMERA & Design, as properly recorded and reflected within the Assignment Division of the USPTO, follows:
  - (a) Boulder Publishing, Inc. registered the mark on April 23, 1996;
  - (b) Boulder Publishing, Inc. assigned the mark to Knight-Ridder Int'l, Inc. on August 5, 1996;
  - (c) Knight-Ridder Int'l, Inc. assigned the mark to K.R. USA, Inc. on August 5, 1996;

(d) K.R. USA, Inc. assigned the mark back to Boulder Publishing, Inc. on August 1, 1997;

(e) Boulder Publishing, Inc. assigned the mark to Monterey County Herald Company on August 24, 1997;

(f) Monterey County Herald Company changed its name to BRV, Inc. on September 11, 1997;

(g) BRV, Inc. merged into Scripps Howard Productions, Inc. on December 17, 1998; and,

(h) Scripps Howard Productions, Inc. changed its name to BRV, Inc. on December 23, 1998.

4. As a longstanding member of the newspaper publishing industry, it is my understanding that Boulder Publishing, Inc., Knight-Ridder Int'l, Inc. and K.R. USA, Inc., were all related companies of one another and were collectively known as "Knight-Ridder";

5. The Boulder Publishing Company, LLC is a wholly-owned subsidiary of The E.W. Scripps Company ("Scripps"). Scripps, through its related companies, acquired all right and title to U.S. Trademark Registration No. 1,969,849, for DAILY CAMERA & Design by assignment from Boulder Publishing, Inc. (a Knight-Ridder subsidiary) to Monterey County Herald Company (a Scripps subsidiary) on August 24, 1997;

6. Since August 24, 1997, the correct owners of U.S. Trademark Registration No. 1,969,849, for DAILY CAMERA & Design have been related companies of Scripps, namely Monterey County Herald Company, BRV, Inc., Scripps Howard Productions, Inc., and The Boulder Publishing Company, LLC;

7. On October 17, 2006, an individual by the name of Karole Morgan-Prager, Esq., erroneously executed an assignment, naming herself as the Executive Vice President and Assistant Corporate Secretary of The Boulder Publishing Company, LLC, wherein U.S. Trademark Registration No. 1,969,849, for DAILY CAMERA & Design was assigned to K.R. USA, Inc., and subsequently recorded at reel and frame 3417/0850 in the Assignment Services Division on October 30, 2006;

8. As Vice President & Secretary of The Boulder Publishing Company, LLC, I have personal knowledge that Karole Morgan-Prager, Esq. is not now, nor has ever been, an officer, agent, employee, attorney or otherwise authorized personnel of The Boulder Publishing Company, LLC and had no authority to either execute the subject document, or to cause the subject document to be recorded at reel and frame 3417/0850;

9. As Vice President & Secretary of The Boulder Publishing Company, LLC, I have personal knowledge that there has been no assignment of right or title to U.S. Trademark Registration No. 1,969,849, for DAILY CAMERA & Design to any third party, nor has any third party been licensed or otherwise authorized to use the DAILY CAMERA & Design trademark;


10. Since September 15, 2000, The Boulder Publishing Company, LLC has been the correct owner of U.S. Trademark Registration No. 1,969,849, for DAILY CAMERA & Design, is now the correct owner of U.S. Trademark Registration No. 1,969,849, for DAILY CAMERA & Design, and should again be correctly recognized as such in the United States Patent & Trademark Office;

11. I declare further that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true and further that these statements were made with the knowledge that willful false statements and the like are

punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of this application and any registration resulting therefrom.

I, Missy Miller, in accordance with TMEP § 503.06(c), declare that:

1. I am authorized to sign on behalf of Prairie Mountain Publishing Company LLP;
2. Based on my review of documents provided to me and my discussions with persons involved in the events stated herein, I have knowledge of the facts pertaining to ownership of Registration No. 1,969,849, for DAILY CAMERA and Design;
3. I am making this declaration to the best of my knowledge that third parties have caused erroneous transfers to be recorded at the USPTO against U.S. Trademark Registration No. 1,969,849, for DAILY CAMERA and Design;
4. Prairie Mountain Publishing Company LLP is the true and correct current owner of Registration No. 1,969,849, for DAILY CAMERA and Design;
5. The true and correct chain of title for U.S. Trademark Registration No. 1,969,849 for DAILY CAMERA & Design, as properly recorded and reflected within the Assignment Division of the USPTO, is as follows:
  - a. April 23, 1996 – Registered in the name of Boulder Publishing, Inc., which was a subsidiary of Knight-Ridder International, Inc.;
  - b. August 1, 1996 – Knight-Ridder International, Inc. assigns entire interest to Boulder Publishing, Inc. (Note: Boulder Publishing, Inc. was the original Registrant, so this assignment is invalid.);

- c. August 5, 1996 – Boulder Publishing Inc. assigns “an undivided part of assignor’s interest” to Knight-Ridder International Inc.;
- d. August 5, 1996 – Knight-Ridder International, Inc. assigns the entire interest to KR U.S.A., Inc.;
- e. August 1, 1997 – KR U.S.A., Inc. assigns to Boulder Publishing, Inc.;
- f. August 24, 1997 – Boulder Publishing, Inc. assigns the entire interest to Monterey County Herald Company;
- g. August 29, 1997 – Monterey County Herald Company changes name to BRV, Inc.;
- h. December 17, 1998 – BRV, Inc. merges into Scripps Howard Productions, Inc.;
- i. December 23, 1998 – Scripps Howard Productions, Inc. changes name to BRV, Inc.; and
- j. September 15, 2000 – BRV, Inc. assigns the entire interest to The Boulder Publishing Company, LLC.

The above recorded transfers are true and correct;

6. The USPTO assignment history for Registration No. 1,969,849, for DAILY CAMERA and Design then contains several purported assignments subsequent to March 6, 2006 that are erroneous;

7. The erroneous transfers are located at Reel/Frame numbers 3417/0850, 3657/0436, 4130/0207, 4130/0278, 4134/0332, and 4690/0454.

8. Prairie Mountain Publishing Company LLP submits that the following historical transfers properly follow the above true and correct recorded transfers:

- a. February 1, 2006 – The Boulder Publishing Company, LLC assigns the entire interest to Colorado Publishing Company LLP; and
- b. March 6, 2006 – Colorado Publishing Company LLP changes name to Prairie Mountain Publishing Company LLP.

9. Prairie Mountain Publishing Company LLP has submitted or will be submitting evidence of the above historical transfers for recordation with the Assignment Services Division;

10. The purported assignments subsequent to March 6, 2006 were erroneous because Prairie Mountain Publishing Company LLP has not transferred Registration No. 1,969,849, for DAILY CAMERA and Design to any third party and Prairie Mountain Publishing Company LLP has been the correct owner since March 6, 2006;

11. Further, the subsequent purported assignments do not list Prairie Mountain Publishing Company LLP as the assignor, but rather they list the names of entities that never or no longer owned Registration No. 1,969,849, for DAILY CAMERA and Design at the time the purported assignments were effective; and

12. Accordingly, Prairie Mountain Publishing Company LLP has been and continues to be the true and correct owner of Registration No. 1,969,849, for DAILY CAMERA and Design.
