FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, SCRIPPS MEDIA, INC., a Delaware corporation (the "Grantor"), with principal offices at 312 Walnut Street, 2800 Scripps Center, Cincinnati, Ohio 45202 on this 30th day of December, 2011, assigns and grants to SUNTRUST BANK, as Administrative Agent (together with its successors and assigns, the "Grantee") with principal offices at 303 Peachtree Street, NE, 23<sup>rd</sup> Floor, Atlanta, Georgia 30308, a security interest in (i) all of the Grantor's right, title and interest in and to the trademarks, trademark registrations, trademark applications and trademark licenses (the "Trademarks") set forth on Schedule A attached hereto and all reissues, extensions or renewals thereof; (ii) all of the Grantor's right, title and interest in and to the patents, patent applications and patent licenses (the "Patents") set forth on Schedule B attached hereto and all reissues, continuations, continuations-in-part and extensions thereof, in each case together with (iii) all Proceeds (as such term is defined in the Pledge and Security Agreement referred to below) of the Trademarks and Patents, (iv) the goodwill of the businesses with which the Trademarks are associated, and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Trademarks and Patents or unfair competition regarding the same.

THIS GRANT OF SECURITY INTEREST (this "Grant"), is made to secure the satisfactory performance and payment of all the "Secured Obligations" of the Grantor, as such term is defined in that certain Pledge and Security Agreement among Grantor, the other grantors from time to time party thereto and the Grantee, dated as of December 30, 2011 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Pledge and Security Agreement").

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Pledge and Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Pledge and Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Pledge and Security Agreement, the provisions of the Pledge and Security Agreement shall govern. This Grant may be executed in counterparts.

I, Missy Miller, in accordance with TMEP § 503.06(c), declare that:

1. I am authorized to sign on behalf of Prairie Mountain Publishing Company LLP;
2. Based on my review of documents provided to me and my discussions with persons involved in the events stated herein, I have knowledge of the facts pertaining to ownership of Registration No. 1,969,849, for DAILY CAMERA and Design;
3. I am making this declaration to the best of my knowledge that third parties have caused erroneous transfers to be recorded at the USPTO against U.S. Trademark Registration No. 1,969,849, for DAILY CAMERA and Design;
4. Prairie Mountain Publishing Company LLP is the true and correct current owner of Registration No. 1,969,849, for DAILY CAMERA and Design;
5. The true and correct chain of title for U.S. Trademark Registration No. 1,969,849 for DAILY CAMERA & Design, as properly recorded and reflected within the Assignment Division of the USPTO, is as follows:
  - a. April 23, 1996 – Registered in the name of Boulder Publishing, Inc., which was a subsidiary of Knight-Ridder International, Inc.;
  - b. August 1, 1996 – Knight-Ridder International, Inc. assigns entire interest to Boulder Publishing, Inc. (Note: Boulder Publishing, Inc. was the original Registrant, so this assignment is invalid.);

- c. August 5, 1996 – Boulder Publishing Inc. assigns “an undivided part of assignor’s interest” to Knight-Ridder International Inc.;
- d. August 5, 1996 – Knight-Ridder International, Inc. assigns the entire interest to KR U.S.A., Inc.;
- e. August 1, 1997 – KR U.S.A., Inc. assigns to Boulder Publishing, Inc.;
- f. August 24, 1997 – Boulder Publishing, Inc. assigns the entire interest to Monterey County Herald Company;
- g. August 29, 1997 – Monterey County Herald Company changes name to BRV, Inc.;
- h. December 17, 1998 – BRV, Inc. merges into Scripps Howard Productions, Inc.;
- i. December 23, 1998 – Scripps Howard Productions, Inc. changes name to BRV, Inc.; and
- j. September 15, 2000 – BRV, Inc. assigns the entire interest to The Boulder Publishing Company, LLC.

The above recorded transfers are true and correct;

6. The USPTO assignment history for Registration No. 1,969,849, for DAILY CAMERA and Design then contains several purported assignments subsequent to March 6, 2006 that are erroneous;

7. The erroneous transfers are located at Reel/Frame numbers 3417/0850, 3657/0436, 4130/0207, 4130/0278, 4134/0332, and 4690/0454.

8. Prairie Mountain Publishing Company LLP submits that the following historical transfers properly follow the above true and correct recorded transfers:

- a. February 1, 2006 – The Boulder Publishing Company, LLC assigns the entire interest to Colorado Publishing Company LLP; and
- b. March 6, 2006 – Colorado Publishing Company LLP changes name to Prairie Mountain Publishing Company LLP.

9. Prairie Mountain Publishing Company LLP has submitted or will be submitting evidence of the above historical transfers for recordation with the Assignment Services Division;

10. The purported assignments subsequent to March 6, 2006 were erroneous because Prairie Mountain Publishing Company LLP has not transferred Registration No. 1,969,849, for DAILY CAMERA and Design to any third party and Prairie Mountain Publishing Company LLP has been the correct owner since March 6, 2006;

11. Further, the subsequent purported assignments do not list Prairie Mountain Publishing Company LLP as the assignor, but rather they list the names of entities that never or no longer owned Registration No. 1,969,849, for DAILY CAMERA and Design at the time the purported assignments were effective; and

12. Accordingly, Prairie Mountain Publishing Company LLP has been and continues to be the true and correct owner of Registration No. 1,969,849, for DAILY CAMERA and Design.
