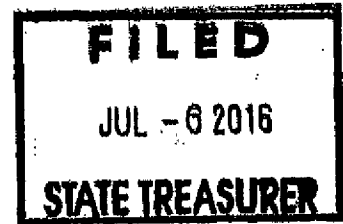

"The name of the corporation is Fourth Edition Inc."


3. The aforesaid amendment was approved by the Board of Directors of the Corporation and thereafter adopted by the shareholders of the Corporation on July 5, 2016.

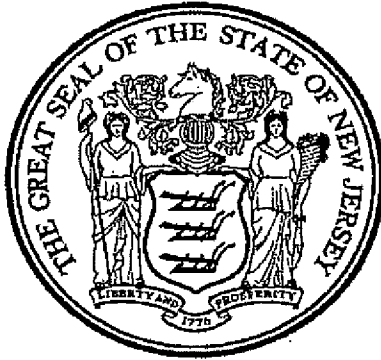
