Trademark Purchase and Assignment Agreement

This Trademark Purchase and Assignment Agreement (the "Agreement") is made as of August 20, 2016, (the "Effective Date"), between *Kevin Williams*, (the "Assignor"), and *Michael Joseph Sulaka*, (the "Assignee").

RECITALS:

Assignor, Kevin Williams, resides at 21769 Hempstead Ave., Queens Village, NY 11429.

The Assignor is the registered owner of a mark, "F.A.M Klothng" that is registered with the United States Patent and Trademark Office, Registration No. 4402918 ("the trademark"), dated September 17, 2013.

Assignee, Michael Joseph Sulaka, resides at 6193 St. James Dr., West Bloomfield, MI 48322.

Collectively, Assignor and Assignee are referred to as the "parties."

PROVISIONS:

The parties agree that Assignee shall pay Assignor \$1,000.00 in exchange for Assignor's conveyance, transfer, and assignment all of his right, title, and interest of whatever kind in the trademark to Assignee, together with

- 1) the goodwill of the business relating to the products and services on which the trademark is used and for which it is registered,
- 2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the trademark, including without limitation, damages, and payments for past or future infringements and misappropriations of the trademark, and
- 3) all rights to sue for past, present and future infringement or misappropriations of the trademark.

If and when Assignor finds the original trademark registration certificate for Registration No. 4402918, Assignor agrees to provide notice of such discovery to Assignee and to deliver said certificate to Assignee.

The Assignor further covenants that Assignor will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the mark and its related property.

If any dispute arises, the matter shall be handled within the forum of the state of Michigan.
