Assignor does hereby assign and transfer unto Assignee Assignor's entire and undivided right, title and interest in and to the Assigned Trademark, together with all the associated goodwill of its business symbolized by the Assigned Trademark, and all applications and registrations of the Assigned Trademark, as well as all rights to injunctive relief, damages and profits, due or accrued, arising out of all causes of action, past, present and future, including infringement of the Assigned Trademark, or other violations, or injury to the said goodwill, and the right to sue for and recover the same in Assignee's own name and the names of Assignee's successors, assigns or other legal representatives.

Assignor shall execute such other or additional instruments of transfer or conveyance and undertake such other or additional actions in respect of the Assigned Trademark as are reasonably requested by Assignee to effectuate the full and complete transfer of the Assigned Trademark.

This Assignment shall be construed and enforced in accordance with the laws of the State of Ohio, without regard to principles of conflicts of law.

This Assignment may be executed in counterparts, which together shall constitute one and the same agreement.
