RELEASE OF TRADEMARK SECURITY INTEREST (First Lien), dated as of August 29, 2016 and with effect as of October 29, 2010 (this "Release"), by Credit Suisse AG, Cayman Islands Branch, in its capacity as Administrative Agent and Collateral Agent (as defined below) and as a Swing Line Lender and an Issuing Bank, in favor of the Company (as defined below). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Joinder Agreement, as applicable, referred to below.

Reference is made to (i) the Amended and Restated Credit Agreement dated as of January 31, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Vertafore, Inc., a Delaware corporation (the "Company"), VF Holding Corp., a Delaware corporation ("Holdings"), the Lenders party thereto, Credit Suisse, Cayman Islands Branch, as administrative agent and as collateral agent (in such capacities, the "Administrative Agent" and the "Collateral Agent" respectively) and as a Swing Line Lender and an Issuing Bank, and the other agents party thereto and (ii) the Subsidiary Joinder Agreement, dated as of September 8, 2006 (as supplemented or otherwise modified from time to time, the "Joinder Agreement"), among the Benefitpoint Holding Corp., a Delaware corporation, Benefitpoint Inc., a Delaware corporation (each, "Subsidiary", and collectively, "Subsidiaries") and the Collateral Agent.

WHEREAS, pursuant to the Credit Agreement and the Joinder Agreement, the Subsidiaries granted a security interest to the Collateral Agent, for the benefit of the Secured Parties in the Collateral (as defined in the Joinder Agreement), including in, among other things, the trademarks of the Subsidiaries set forth on Schedule I hereto (the "Trademarks"), which security interest was recorded with the United States Patent & Trademark Office on March 12, 2007 at Reel/Frame 003497/0518.

WHEREAS, in connection with the termination of the Credit Agreement and the Joinder Agreement, which occurred on October 29, 2010, the Company has informed the Collateral Agent of its desire to obtain the release of all right, title and interest of the Collateral Agent in and to the Trademarks.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release, cancel, relinquish, terminate and discharge any and all security interests it has against the Collateral and reassigns all right, title and interest it may have in the Collateral to the applicable Subsidiary. The Collateral Agent authorizes the Company to file this Release with the United States Patent and Trademark Office to evidence the release and termination of the Collateral Agent's security interests in the Trademarks made hereunder. The Collateral Agent shall take all further actions and provide to the Company, assigns or other legal representatives all such cooperation and assistance, as reasonably requested by the Company and at the sole cost and expense of the Company, to more fully and effectively effectuate the purposes of this Release. The execution and/or delivery of this Release by the Collateral Agent shall be without recourse to or warranty by the Collateral Agent or any Secured Party.

THIS RELEASE SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK AND




