WHEREAS, Assignee desires to acquire all of the right, title and interest in and to the Marks, including the goodwill associated therewith.



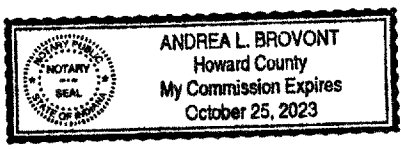
