NOW THEREFORE, for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged by the parties, ASSIGNOR does hereby assign, transfer, grant, convey and set over unto ASSIGNEE, its successors and assigns, all of ASSIGNOR's right, title and interest in and to all trademarks, trade names, service marks, corporate names, copyrights, mask works, patents, patent applications, trade secrets and/or other intellectual property rights used in, developed for use in or necessary to conduct the PONY Business (including the rights to institute or maintain any action or investigation for and to recover damages for any past infringement thereof or any actions of unfair competition relating thereto), including, without limitation, all of ASSIGNOR's rights title and interest in and to the following:

(a) the name "Adjustable Clamp Company", "Pony Tools Incorporated", "Pony Tools", "Jorgensen" and/or any combination of words in which such names appear and all rights associated with such names or any right to use such name in all jurisdictions, any records associated with such assumed names, and any and all trademark registrations/applications relating to such names, together with all goodwill associated with such names;

(b) all trademarks and service marks listed in Schedule 1 attached to this Assignment (hereinafter "MARKS") in all countries throughout the world, together with all goodwill associated with the MARKS, all registrations for the MARKS, and all rights to any and all causes of action and/or remedies related to the MARKS (including the right to sue for past, present and/or future infringement, misappropriation or violation of rights relating to the MARKS);

(c) all domain names, social media sites and websites of the PONY BUSINESS and the right to use such domain names, social media sites and websites used at or for the PONY BUSINESS, including ponytools.com, and all rights in the content contained on said domain names, social media sites and websites;

(d) any and all of ASSIGNOR's trademark and/or trade dress rights in the color orange (PMS 165C) as used in connection with the sale of clamp related tools, including, without limitation, the goodwill associated therewith and any and all registrations for said trademark/trade dress rights;

(e) all patents and patent applications listed in Schedule 2 attached to this Assignment (hereinafter "PATENTS"), and any and all patents issuing from any and all continuation, divisional, renewal, substitute and/or reissue applications of said PATENTS throughout the world;

(f) all rights in all computer software, both source and object codes, relating to the PONY BUSINESS;


(g) all rights in the works listed in Schedule 3 of this Assignment (hereinafter "WORKS"), including the unencumbered right to exercise such rights in all media and by any manner or means, whether now or hereafter devised, throughout the world, including all copyright registrations and renewals or extensions for said WORKS; and

ASSIGNOR agrees to waive any and all moral rights relating to any and all of the above referenced intellectual property, including without limitation any and all rights of approval, restriction or limitation on use or subsequent modifications.

ASSIGNOR, whenever reasonably requested by ASSIGNEE, shall execute and deliver any and all other documents and/or instruments necessary to vest all of ASSIGNOR's rights, title and interest in the above referenced intellectual property to ASSIGNEE.

This Assignment may be executed in one or more counterparts, each of which when so executed and delivered shall be deemed to be an original, and multiple copies of this Assignment may be executed.

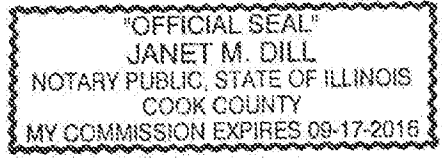

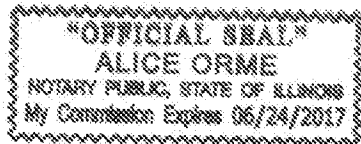
