ASSIGNMENT OF TRADEMARK

WHEREAS, Kinder Morgan, Inc., a Delaware corporation (hereinafter referred to as “Assignor”), owns and has used in business the following trademark, SOUTHERN NATURAL GAS, together with the goodwill of the business symbolized thereby and associated therewith, as well as United States Trademark Registration No. 2,721,507 issued therefore (the foregoing collectively referred to as “the Mark”); and

WHEREAS, Southern Natural Gas Company, L.L.C., a Delaware limited liability company (hereinafter referred to as “Assignee”), is desirous of acquiring all of the right, title, and interest of Assignor in and to the Mark, and in and to any renewals and extensions that may be granted thereon, together with the goodwill of the business connected therewith;

THEREFORE, BE IT KNOWN that for and in consideration of the sum of Ten Dollar (\$10.00) to it in hand paid, and other good and valuable consideration, the adequacy, legal sufficiency, and receipt of which is hereby acknowledged, the parties agree on this 29th day of August, 2016, as follows:

1. Assignor hereby assigns, transfers and conveys to the Assignee, and the Assignee hereby accepts and assumes, free and clear of any encumbrances, all right, title and interest in and to the Mark as described above, together with the goodwill of the business symbolized by the Mark, the applications for registration and registrations therefor, including, but not limited to, the right to use the Mark in Assignee’s trade names and corporate names, and the right to sue for and be entitled to any damages for infringement of the Mark and all claims for damages arising out of or relating to past or continuing infringements thereof, if any, with the right to sue for and collect such damages.

2. The rights assigned hereby include, without limitation all of the Assignor’s right to sue and recover for any past, present, and future infringement or unauthorized use of any right or interest in the Mark.

3. Assignor hereby authorizes and requests the Commissioner of Trademarks at the United States Patent and Trademark Office, and any similar foreign trademark authorities, to record this Assignment and hereby represents and warrants that the Assignor has the full right to convey the entire interest herein assigned.

4. Assignor agrees to execute any further lawful documents and take any other actions reasonably necessary to fully protect and vest in the Assignee the assigned rights and interests in the Mark.

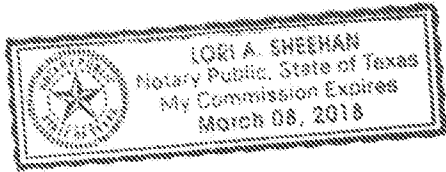
