
ASSIGNMENT OF TRADEMARK

Hereafter, Assignee shall have the benefit of all trademarks, copyright, rights of publicity and any and all other rights of any kind or description relating to the Property which may be owned by Assignor, to enforce and protect the rights and privileges conveyed under the common law or statutory law of any country; to obtain, renew and extend the rights conferred hereunder; to prevent the infringement of the rights conferred hereunder, and also to litigate, collect and receive all damages arising from interference with or infringement of any and all such rights and to collect all damages, penalties and settlements and profits relating to or arising from any commercial use, interference or infringement of the rights granted Assignee hereunder.


