## TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST

This TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST ("Termination and Release") dated as of August 22, 2016, is made by The PrivateBank and Trust Company ("Lender") to Renwood Mills, LLC (the "Grantor"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Loan Agreement (defined below) or the Trademark Security Agreement (defined below), as applicable.

### WITNESSETH:

WHEREAS, pursuant to that certain Loan and Security Agreement dated as of June 10, 2013, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), by and among the Grantor, the Lender, the Grantor executed that certain Trademark Security Agreement, dated as of June 10, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), which was recorded in the United States Patent and Trademark Office at Trademark Reel 5048 Frame 0818, pursuant to which the Grantor granted a security interest to Lender, in the Trademarks, including certain trademarks and/or trademark applications listed on Schedule A hereto and made a part hereof.

1. Lender hereby releases its security interest in all of Grantor's right, title and interest in and to the Trademarks, including those trademarks set forth on Schedule A.
2. If and to the extent that Lender has acquired any right, title or interest in or to any of the Trademarks, Lender hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by Lender, any and all of Lender's right, title, and interest in and to the Trademarks, along with any goodwill in the Trademarks that Lender may have acquired.
