NOTICE OF RELEASE OF SECURITY INTEREST

This Notice of Release of Security Interest (the "Release") is effective as of August 31, 2016, by **PNC BANK, NATIONAL ASSOCIATION** (together with its successors, "Secured Party").

WHEREAS, reference is made to that certain Trademark Security Agreement, dated as of January 6, 2016 (the "Trademark Security Agreement"), by **TECTA AMERICA CORP.**, a Wisconsin corporation, **TECTA AMERICA DAKOTAS LLC**, a North Dakota limited liability company, **F.J.A. WHEREAS, pursuant to the Trademark Security Agreement and the Security Agreement (as defined in the Trademark Security Agreement), each Grantor granted to the Secured Party a security interest in certain of such Grantor's assets, including, without limitation, the trademarks ("Intellectual Property") owned by such Grantor as described in the Trademark Security Agreement; and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 7, 2016 at Reel/Frame 5704/0477;


NOW, THEREFORE, intending to be legally bound hereby and in connection with the Trademark Security Agreement and the Security Agreement (as defined in the Trademark Security Agreement), Secured Party hereby releases and remits, without any recourse, representation or warranty, any and all rights, title and interests in and to the Intellectual Property, including, without limitation, the trademarks set forth on Exhibit A attached hereto, and hereby authorizes each Grantor or each such Grantor's authorized representative to record this Release with the United States Patent and Trademark Office as evidence of such release. Secured Party further agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that each Grantor may reasonably require to effect the intent and purpose of this Release, provided that all such documents shall be prepared by such Grantor's counsel and the cost and expense of such documents and actions shall be borne solely by such Grantor.
