
connection with the Mark including, but not limited to, the right to sue and recover damages for any and all past infringements of the Mark.

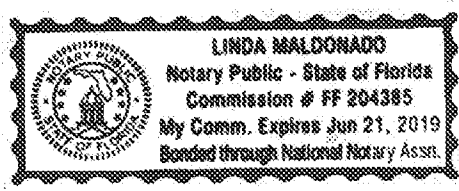
