WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to Administrative Agent, for the benefit of the Secured Parties, (a) the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office ("<u>USPTO</u>") on August 13, 2015 at Reel 5598 Frame 0935 ("<u>First Notice</u>"), (b) the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office ("<u>USPTO</u>") on January 29, 2016 at Reel 5719 Frame 0693 (the "<u>Second Notice</u>") and (c) the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office ("<u>USPTO</u>") on June 10, 2016 at Reel 5812 Frame 0341 (the "<u>Third Notice</u>" and, together with the First Notice and the Second Notice, the "<u>Notices</u>").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Grantor agree as follows:

- **SECTION 1**. <u>Defined Terms</u>. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or the Notices, as applicable.
- **SECTION 2**. <u>Termination and Release</u>. Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:
- (a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to, and the right to set off against, Grantor's right, title, and interest in and to all the Trademark Collateral, including, but not limited to, (i) the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or the First Notice, (ii) the foregoing listed on Schedule B attached hereto, granted pursuant to the Security Agreement or the Second Notice and (iii) the foregoing listed on Schedule C attached hereto, granted pursuant to the Security Agreement or the Third Notice; and
 - (b) authorizes the recordation of this Release with the USPTO at Grantor's expense.
- **SECTION 3**. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
