Alpha Moda Lab, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the "General Corporation Law"),

DOES HEREBY CERTIFY:

1. Pursuant to Section 242 of the General Corporation Law, this Certificate of Amendment to the Amended and Restated Certificate of Incorporation (this "Amendment") amends the provisions of the Amended and Restated Certificate of Incorporation of the Corporation (the "Certificate").

2. This Amendment has been approved and duly adopted by the Corporation's Board of Directors and written consent of the stockholders has been given in accordance with the provisions of Sections 228 and 242 of the General Corporation Law, and the provisions of the Certificate.

3. Article I of the Certificate is hereby amended and restated in its entirety to read as follows:

"The name of this corporation is MATCHCo. (the "Corporation")."

4. Article IV of the Certificate is hereby amended and restated in its entirety to read as set forth below:

"The total number of shares of all classes of stock which the Corporation shall have authority to issue is (i) 18,934,754 shares of Common Stock, \$0.0001 par value per share ("Common Stock") and (ii) 3,934,754 shares of Preferred Stock, \$0.0001 par value per share ("Preferred Stock")."
