## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of August 30, 2016 by **SARATOGA INVESTMENT CORP.**, as Administrative Agent (the "*Assignee*"), in favor of **FINALSITE HOLDINGS, INC.**, a Delaware corporation (the "*Grantor*").

**WHEREAS**, the Grantor has requested that the Assignee provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the Trademarks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:


