**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK  
COLLATERAL**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”) is made as of September 1, 2016 (“Effective Date”), by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association, in its capacity as agent for the Lender Group and the Bank Product Providers, as such terms are defined in the below defined Credit Agreement (together with its successors in such capacity, “Grantee”), in favor of **ARCHIMEDES, INC., EVIDERA HOLDINGS, INC.** (f/k/a Evidera, Inc.), **EVIDERA, INC.** (f/k/a UBC Health Care Analytics, Inc.), and **EVIDERA LLC** (f/k/a Scientific Practices LLC) (each a “Grantor” and collectively, the “Grantors”).

**WHEREAS**, reference is made to that certain Credit Agreement, dated as of September 4, 2013 (as amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”), by and among the lenders identified on the signature pages thereof, Grantee, certain of the Grantors, and the other parties signatory thereto;

**WHEREAS**, pursuant to the terms and conditions of (1) that certain Trademark Security Agreement, dated as of September 4, 2013, by and among certain Grantors and Grantee, which was recorded with the United States Patent and Trademark Office on September 9, 2013 at Reel 51407, Frame 0409, and (2) that certain Amendment Number One to Trademark Security Agreement, dated as of February 3, 2014, by and among certain Grantors and Grantee, which was recorded with the United States Patent and Trademark Office on February 5, 2014 at Reel 5209, Frame 0778 (the documents set forth in items (1) and (2) above, as amended, restated, supplemented, or otherwise modified and in effect from time to time, collectively the “Trademark Security Agreement”), the Grantors granted to Grantee a security interest in all of the Grantors’ right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement); and

**WHEREAS**, Grantee now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on **Schedule 1** hereto.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement, and reassigns to Grantors all right, title, and interest of Grantee in the Trademark Collateral pursuant to the Trademark Security Agreement.

2. Grantee hereby authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

3. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantors’ expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.
