**TERMINATION AND RELEASE OF
GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination"), is dated as of September 2, 2016, and made by Jefferies Finance LLC, as administrative agent and collateral agent for the Secured Parties (in such capacity, the "Administrative Agent") having an office at 520 Madison Avenue, New York, New York 10022 ("Jefferies") to SkinnyPop Popcorn LLC (formerly known as TA Midco 1, LLC), a Delaware limited liability company, located at 8135 Monticello Ave., Skokie, IL 60076 (the "Grantor").

WHEREAS, pursuant to the Grant of Security Interest in United States Trademarks dated as of July 17, 2014 by the Grantor and Jefferies Finance LLC, as Administrative Agent (the "Trademark Security Agreement") certain security interests (the "Interests") were granted by the Grantor to Jefferies in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Interests were recorded in the Assignment Division of the United States Patent and Trademark Office on July 17, 2014, at Reel 5324 and Frame 0656; and

WHEREAS, the Grantor requested that Jefferies terminate and release the Interests.

NOW, THEREFORE, for good and valuable consideration, Jefferies hereby states as follows:


1. Definitions. The term "Trademarks", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto. Capitalized terms used herein without definition are used as defined in the Trademark Security Agreement, or if not defined in the Trademark Security Agreement, are used as defined in that certain Security Agreement referenced therein.

2. Release of Security Interest. Jefferies hereby terminates the Interests and terminates, releases and discharges its interest in the Trademarks.
