This Assignment is executed and delivered pursuant to the Agreement and is in all respects subject to the terms, conditions and other provisions thereof. Nothing in this Assignment is intended to modify, amend or alter in any respect the rights and obligations of the Parties under the Agreement, which will remain in full force and effect notwithstanding the execution and delivery of this Assignment.

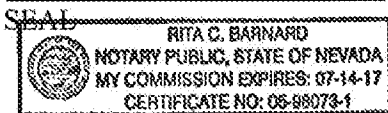
