TRADEMARK ASSIGNMENT AGREEMENT (US)

This TRADEMARK ASSIGNMENT AGREEMENT, (this "Assignment"), dated effective as of July 1, 2016, is executed and delivered by Green Harbour Pty Ltd, ITF The Green Family Trust TA Kit Bag, an Australian proprietary limited company ("Assignor"), to US Tactical Systems, Inc., a Missouri corporation ("Assignee").

WHEREAS, Assignor is the owner of the following trademark: RECON, a standard character mark that is the subject of U.S. common law rights and a registration with the U.S. Patent and Trademark Office, Registration No. 4,192,644;

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to acquire from Assignor, all right, title and interest in and to the above-identified mark and registration (collectively, the "Mark"), including, without limitation, all U.S. common law rights relating to the Mark and all renewals and extensions that may be granted in connection with the registration; and

WHEREAS, pursuant to the terms of that certain Intellectual Property Agreement, dated as of July 1, 2016 (the "Agreement"), among Assignor and Assignee, Assignor has agreed to transfer and Assignee has agreed to accept such transfer of trademark rights from Assignor.

NOW, THEREFORE, pursuant to the terms of the Agreement and for the consideration set forth therein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned hereby agree as follows:

1. Assignor hereby sells, assigns, transfers, conveys and delivers to Assignee and its successors, assigns and nominees absolutely and forever, all of Assignor's right, title and interest in and to the Mark, and all other rights that Assignor has enjoyed thereunder in the United States, including, without limitation, all rights and remedies based upon past infringement, including the right to sue and collect damages and profits for such infringement.
2. Assignor covenants and agrees that it will, at any time, on request, execute and deliver any and all papers that may be necessary or desirable to perfect the title to the aforementioned assets and rights assigned by this Assignment.
