By and Between

DEVA SINGH SHAM SINGH, a partnership firm, comprising of the Partners, Mr. Ravinder Pal Singh Chatha, Mr. Kunwar Raj Singh Sobti and Chatha Rice Industries Private Limited, having its registered office at Outside Chatiwind Gate, Amritsar – 143 001, India, (hereinafter called the "**Assignor**" which expression shall, unless repugnant to the context or meaning hereof, be deemed to include its successors, receivers and permitted assigns) of the **FIRST PART**;

And

LT FOODS INTERNATIONAL LIMITED, a company incorporated and existing under the laws of the United Kingdom, having its registered office at Legal Linx Limited, 1 Fetter Lane, London, United Kingdom, EC4A1BR (hereinafter called the "**Assignee**" which expression shall, unless repugnant to the context or meaning hereof, be deemed to include its successors, receivers and permitted assigns) of the **SECOND PART**.

WHEREAS Parties have executed a Trademark Assignment Agreement effective July 15, 2016 with respect to a number of Trademarks, Trademark registrations and Trademark applications throughout the world ("**Trademarks**") and Parties wish to record such assignment of Trademarks in the relevant jurisdictions, as listed and set forth in the Schedule A hereto.

NOW THEREFORE THIS CONFIRMATORY ASSIGNMENT AGREEMENT WITNESSETH:

The Assignor, has irrevocably and absolutely assigned, transferred and conveyed as of July 15, 2016, all rights, title and interest as Assignor did possess, including, but not limited to, all common law rights, trade name rights, causes of action, and

the right to recover for past infringement worldwide, in and to the Trademarks, together with the goodwill and business appurtenant thereto and symbolized thereby and certain tangible assets as indicia of said goodwill.



The Assignor agrees and undertakes that it shall at any and all times, upon request by the Assignee, or its legal representative, make, sign, execute, and deliver, any and all such other and further instruments, deeds and documents as may be necessary or desirable to vest, perfect and maintain the Trademarks and for the purpose of giving full force and effect to the provisions of this Deed. The Assignor agrees that it shall cooperate with the Assignee in ensuring that the Assignee becomes and is recorded as the subsequent proprietor of the Trademarks.


