## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is given on September 7, 2016, by LATERAL U.S. CREDIT OPPORTUNITIES FUND, L.P., as administrative agent (the "Agent") for the Secured Parties (as defined in the Credit Agreement referred to below) to DACOR, a California corporation (the "Grantor").

WHEREAS, reference is made to that Credit Agreement, dated as of May 6, 2016 (as amended, restated, supplemented and/or modified prior to the date hereof, the "Credit Agreement"), among, *inter alios*, Grantor, the other Credit Parties, the Lenders from time to time party thereto and the Agent;

WHEREAS, the Grantor and the Agent are party to a Trademark Security Agreement dated as of May 6, 2016 (the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor mortgaged, pledged, and hypothecated to the Agent for the benefit of the Secured Parties, and granted to the Agent for the benefit of the Secured Parties, a Lien on and continuing security interest in all of the Grantor's right, title and interest in, to and under the Trademark Collateral (as that term is defined in the Trademark Security Agreement) (which Trademark Collateral includes, without limitation, the United States trademarks listed on the attached Schedule A (the "Trademarks"));

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent & Trademark Office on May 6, 2016 at reel/frame 5788/0952;

WHEREAS, the Agent wishes to terminate and release the security interest and all other Liens of the Agent and the Secured Parties in and to the Trademark Collateral (including in and to the Trademarks) and retransfer and reassign to the Grantor without recourse all of the Agent's and Secured Parties' right, title and interest in and to the Trademark Collateral (including all such right, title, and interest in and to the Trademarks).

NOW THEREFORE, the Agent, for itself and for the Secured Parties, hereby terminates and releases any security interest or other Lien they may have in or to the Trademark Collateral (including in or to the Trademarks), and reassigns any and all right, title and interest it or the Secured Parties may have in and to the Trademark Collateral (including in or to the Trademarks) without recourse to the relevant Grantor.

FURTHERMORE, the Agent hereby authorizes the Grantor and its authorized representatives to record this Release of Trademark Security Interest with the United States Patent and Trademark Office.
