ASSIGNMENT OF TRADEMARK AND OTHER RIGHTS

EFFECTIVE AS OF AUGUST 8, 2016, **KELLY CRAIG KULIKOFF**, a citizen of the United States having an address at 8537 Satinwood Avenue, California City, California 93505 ("*Assignor*"),

and

FCH ENTERPRISES INC, a Hawaii corporation with a principal place of business located at 1765 South King Street, Honolulu, Hawaii 96826 ("*Assignee*"),

agree as follows:

1. Background and Certain Definitions. Pursuant to the terms of a Settlement and Mutual Release Agreement by and between Assignor and Assignee and in settlement of Cancellation No. 92/063198 before the Trademark Trial and Appeal Board of the U.S. Patent and Trademark Office, Assignor desires to assign to Assignee all of Assignor's trademark, service mark, copyright, trade name, and other rights in and to "**ZIPPY PIZZA**," including but not limited to Assignor's U.S. Trademark Registration Nos. 4,571,839 for "**ZIPPY PIZZA** (standard characters) in connection with "Pizza parlors" in International Class 43, and 4,572,151 for "**ZIPPY PIZZA**" (with a design) in connection with "Pizza delivery" in International Class 39 (collectively, hereinafter referred to as the "*Mark*").

2. Assignment. In consideration of the sum of TEN DOLLARS (\$10.00) and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, transfers, and sets over unto Assignee all of Assignor's right, title, and interest in and to the Mark, including but not limited to U.S. Trademark Registration Nos. 4,571,839 for "**ZIPPY PIZZA**" (standard characters) and 4,572,151 for "**ZIPPY PIZZA**" (with a design);

TOGETHER WITH all goodwill symbolized by the Mark;

ALSO, TOGETHER WITH the right to sue for past infringement, if any there may be.

This Assignment shall be binding upon Assignor and Assignor's heirs, personal representatives, devisees, successors, successors in trust, assigns, and affiliates, and shall inure to the benefit of Assignee and Assignee's successors, assigns, and affiliates. This Assignment can be amended only by a written instrument signed by both parties. This Assignment shall be interpreted and enforced under the laws of the State of Hawaii and the United States of America. The courts of the State of Hawaii, and the United States District Court for the District of Hawaii, and no other courts or tribunals, shall have exclusive original jurisdiction over any dispute arising under this Assignment.
