## ASSIGNMENT

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Receiver confirms that it has sold, assigned and transferred, and by those present does sell, assign and transfer unto Rehan Marketing, its successors and assigns, the whole right, title and interest, of every nature and kind of the Receiver and Danier Leather Inc., in and to the Trademarks, together with the goodwill of the business carried on in association with the Trademarks, and all rights of actions and claims, including the right to sue for damages and other remedies in respect of any past violations of the rights in and/or to the Trademarks, in the jurisdictions listed, the same to be held by Rehan Marketing, as fully and effectually as would have been held by the Receiver or Danier Leather Inc., had this assignment and sale not been made.

AND, the Receiver agrees that it will upon request, at the cost of Rehan Marketing, do such things and execute such further documents as may be necessary or desirable to rest all rights, title and interest of the Receiver and Danier Leather Inc. in and to the

Trademarks with Rehan Marketing, its successors and assigns, provided that it incurs no expense in this regard, and if any expense is to be incurred, it is to be funded by Rehan Marketing on terms acceptable to the Receiver.
