**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is dated as of September 6, 2016 by BANK OF AMERICA, N.A., as collateral agent (in such capacity, the "Collateral Agent") for the Secured Parties, in favor of SCIENTIFIC GAMES INTERNATIONAL, INC., SCIENTIFIC GAMES CORPORATION, and PHANTOM EFX, LLC (successor in interest to Phantom EFX, Inc.), an Iowa limited liability company (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

**WHEREAS**, the Grantor, Borrower, the Collateral Agent, and other parties thereto, entered into that certain Guarantee and Collateral Agreement, dated as of October 18, 2013 (the "Security Agreement"), pursuant to which Grantor executed and delivered to the Collateral Agent that certain Trademark Security Agreement, dated as of October 18, 2013 (the "Trademark Security Agreement"), for recordation with the United States Patent and Trademark Office;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 15, 2013 at Reel/Frame 5163/0434;

**WHEREAS**, pursuant to the Security Agreement and the Trademark Security Agreement, the Grantor pledged, collaterally assigned, mortgaged, transferred and granted to the Collateral Agent, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest (the "Security Interest") in all of the Grantor's right, title or interest in, to or under all of the following assets, whether then owned or at any time thereafter acquired by or arising in favor of the Grantor and regardless of where located: (a) all trademarks, trade names, corporate names, company names, business names, domain names, fictitious business names, trade dress, trade styles, service marks, logos and other source or business identifiers, designs and general intangibles of like nature, and all goodwill associated therewith or symbolized thereby, all registrations and recordings thereof, and all applications in connection therewith (except for "intent to use" applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, unless and until an Amendment to Allege Use or a Statement of Use under Section 1(c) or 1(d) of said Act has been filed), whether in the United States Patent and Trademark Office or in any similar office or agency of the United States or any State thereof, and all United States common-law rights related thereto owned by such Grantor in its own name, including, without limitation, any of the foregoing referred to in Schedule I and (b) the right to obtain all renewals thereof (the "Trademark Collateral"); and


**WHEREAS**, the Collateral Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral.

**NOW, THEREFORE**, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent on behalf of the Secured Parties, hereby terminates, releases and forever discharges the Security Interest in the Trademark Collateral, and retransfers and reassigns to the Grantor any right, title or interest the Collateral Agent may have in, to or under the Trademark Collateral.
