NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to the Trademark Security Agreement, dated as of January 21, 2014, by Colomer Beauty Brands USA, Inc., a Delaware corporation, Creative Nail Design, Inc., a California corporation, and Roux Laboratories, Inc., a New York corporation (each a "*Grantor*" and, collectively, the "*Grantors*"), in favor of the Collateral Agent, recorded in the United States Patent and Trademark Office on January 29, 2014 at Reel 5203, Frame 0462 each Grantor, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of such Grantor, mortgaged, pledged and hypothecated to Citicorp USA, Inc., as Collateral Agent (the "*Collateral Agent*"), and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in, all of such Grantor's right, title and interest in, to and under the following Collateral of such Grantor (the "*Trademark Collateral*"): (a) all of its Trademarks and Trademark Licenses to which it is a party, including, without limitation those referred to on Schedule I hereto; (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark; and (c) all Proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present, future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

WHEREAS, pursuant to the Payoff Letter, dated as of September 7, 2016, by and among the Collateral Agent and Revlon Consumer Products Corporation, a Delaware corporation (the "*Company*"), the Company has requested and the Collateral Agent has agreed to procure, execute and deliver to the Company, at the expense of the Company, such documents confirming and carrying out the release and discharge of the Secured Parties' security interest in the Trademark Collateral; and

WHEREAS, the Collateral Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release and discharge of its security interest in the Trademark Collateral.

NOW THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby agree as follows:

1. Release. As of the date listed on the signature page hereto, the Collateral Agent hereby releases and discharges its lien on and security interest in the Trademark Collateral.

2. Further Assurances. The Collateral Agent hereby agrees, at the Company's expense, to execute such instruments and to take such other actions as the Company may reasonably request to terminate the Collateral Agent's security interest in the relevant Trademark Collateral.


3. Governing Law. This Notice of Release of Security Interest in Trademarks shall be governed by and construed and interpreted in accordance with the laws of the State of New York.


