**PARTIAL TERMINATION AND RELEASE OF
SECOND LIEN TRADEMARK SECURITY AGREEMENT**

THIS PARTIAL TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this “**Termination**”), dated as of August 31, 2016, is executed by ROYAL BANK OF CANADA, in its capacity as administrative agent and collateral agent for the Secured Parties (in such capacities, the “**Administrative Agent**”), in favor of RENTPATH, LLC, a Delaware limited liability company and successor by merger to Regal Finance Sub, LLC (the “**Grantor**”). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement, as defined below.

RECITALS

A. Pursuant to that certain (i) Second Lien Trademark Security Agreement, dated as of December 17, 2014 (the “**Trademark Security Agreement**”), among the Grantor, certain Subsidiaries of the Borrower from time to time party thereto and the Administrative Agent and that certain (ii) Security Agreement (as defined in the Trademark Security Agreement), Grantors granted to the Administrative Agent a security interest in certain Trademark Collateral.

B. The Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on December 18, 2014, at Reel/Frame 5421/0623 to evidence the security interest granted under the Trademark Security Agreement.

C. The Administrative Agent agrees to terminate and release its security interest solely in the Released Trademark Collateral specified below and to file this Termination with respect to such release of its security interest in such Released Trademark Collateral as herein provided.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent, on behalf of the Secured Parties, expressly terminates and releases, and reassigns to the Grantors, all of right, title and interest in or to any and all of the following assets and properties (collectively, the “**Released Trademark Collateral**”):

the trademarks, service marks, trade names, corporate names, trade dress, logos, designs, fictitious business names and other source or business identifiers protected under the laws of the United States or any state or political subdivision thereof listed on Schedule I hereto, all registrations and recordings thereof, all registration and recording applications filed in connection therewith in the USPTO, and all renewals thereof, and all goodwill connected with the use thereof and symbolized thereby;

For the avoidance of doubt, nothing contained in this Termination shall be construed as a termination, release, retransfer or reassignment of any security interest, if any, or any right, title and interest which the Administrative Agent may have in the Trademark Collateral which has not been specifically identified on Schedule I attached hereto or any other collateral described in the Security Agreement, the Trademark Security Agreement or otherwise.
