PATENT, PATENT APPLICATION, AND TRADEMARK ASSIGNMENT

This Patent, Patent Application, and Trademark Assignment Agreement (“Assignment”) between L&P Property Management Company and Accent Packaging, Inc., a Texas Corporation with an address at 10131 FM 2920 Road, Tomball, Texas 77375, is made effective the date indicated below.

WHEREAS, Leggett & Platt, Incorporated (“Leggett”) and Accent Packaging, Inc. (“Assignee”), entered into an Asset Purchase Agreement on June 2, 2016 (“the APA”), by which Leggett sold, conveyed, assigned, delivered, and transferred certain assets to Assignee, including the Patents, Patent Applications, and Trademark Registrations listed in Exhibit A (collectively the “Wire Tie Intellectual Property”);

WHEREAS the registered owner of the Wire Tie Intellectual Property is L&P Property Management Company (“Assignor”), an affiliate of Leggett; and

WHEREAS Assignor and Assignee desire to execute a formal assignment of the Wire Tie Intellectual Property from Assignor to Assignee so that Assignee may record the change in ownership of the Wire Tie Intellectual Property with the United States Patent & Trademark Office and foreign patent offices in which the Patent Applications listed in Exhibit A are being prosecuted;

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, including the consideration received by Assignor’s affiliate Leggett under the APA, the receipt, sufficiency and adequacy of which are hereby acknowledged, the parties agree as follows:

1. Assignor does hereby assign to Assignee, the entire right, title and interest for the United States and all foreign countries in and to the Patents and Patent Applications in Exhibit A, including, without limitation, all domestic and foreign patent rights relating to the Patents and Patent Applications listed in Exhibit A, including any divisional, continuing, substitute, renewal, reissue and all other patent applications which have been, or shall be, filed in the United States and all foreign countries on any such inventions; all original and reissued patents which have been or shall be issued in the United States and all foreign countries on such inventions; and specifically including the right to file foreign applications under the provisions of any convention or treaty and claim priority based on such Patent Applications in the United States.
2. Assignor hereby authorizes, and requests, that the Commissioner of Patents issue any and all Letters Patent of the United States on inventions covered by the Patent Applications and from any all divisions, continuations, and reissues thereof to Assignee.
3. Assignor hereby assigns to Assignee all of Assignor’s right, title, and interest throughout the world of whatever kind in any jurisdiction in and to the Trademark

Registrations in Exhibit A, together with any goodwill relating to the goods with which the marks listed in Exhibit A are used and covered by the Trademark Registrations.

4. Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office to record the transfer of the Trademark Registrations to Assignee as assignee of Assignor's entire right, title and interest therein.
5. Assignor further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Intellectual Property in the United States or in foreign patent offices where Patent Applications have been filed or where applications related to the Patents or Patent Applications may be filed.
6. This Assignment is binding on the heirs, assigns, representatives and successors of the undersigned and extends to the successors, assigns and nominees of the Assignee.
7. This Assignment may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument. Each counterpart may be delivered by facsimile transmission, which transmission shall be deemed delivery of an originally executed document.

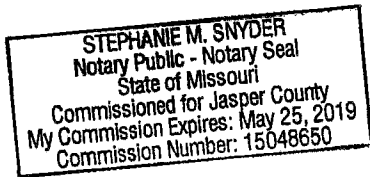

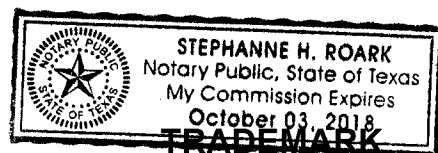
