## TRADEMARK ASSIGNMENT

WHEREAS MMMM/CHC Holding, LLC, a Delaware limited liability corporation, having its principal office at 780 Township Line Road, Yardley, Pennsylvania 19067 USA ("Assignor"), is the original owner of the entire right, title and interest in and to each of the United States trademark registrations set forth on Schedule A hereto ("the Marks"); and

WHEREAS, ICON Clinical Research Limited, an Irish limited company, having its principal office at South County Business Park, Leopardstown, Dublin 18, Ireland ("Assignee"), wished to acquire the entire right, title and interest in and to each of the Marks, including all of the goodwill represented by, associated with, connected with, and symbolized by the Marks;

WHEREAS, the parties entered into an Intellectual Property Transfer Agreement effective March 2, 2015 (the "Agreement") wherein Assignor assigned the Marks to Assignee and the parties now wish to memorialize and record such assignment with the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged as part of the Agreement, Assignor did sell, assign, convey, transfer and set over unto the Assignee, its legal representatives, successors, and assigns, the entire right, title and interest in and to each of the Marks, together with the entire goodwill associated with, represented by, connected with, and symbolized by the Marks, together with all common law rights thereto, together with all rights and privileges granted and secured thereby, including the right to sue for all causes of action related to the Marks, and the right to sue in Assignee's own name and to recover for any damages and profits for past infringement, unfair competition or passing off, said rights to be held and enjoyed by said Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by said Assignor if the Agreement had not been made.

Assignor agrees that it will not execute any writing or do any act whatsoever conflicting with the Agreement, and will, at any time upon request without further or additional consideration but at the expense of Assignee, execute such additional assignments and other writing and do such additional acts as Assignee may deem necessary or desirable to perfect, secure, record, and register Assignee's enjoyment of this grant, it being understood that the foregoing covenant and agreement shall bind assigns and legal representatives of Assignor and inure to the benefit of the assigns and legal representatives of Assignee.

This document is effective *nunc pro tunc* (now as before) as of March 2, 2015.
