TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY

WHEREAS, pursuant to a Security Agreement dated as of December 3, 2012 and corresponding Riders to the Security Agreement dated as of December 3, 2012 (the "Agreement"), Auto Air Export, Inc., d/b/a Omega Environmental Technologies, a Texas corporation, Global Parts Distributors, LLC, a Delaware limited liability company, and Santech Industries, LLC, a Delaware limited liability company (each a "Grantor" and collectively, the "Grantors"), granted a security interest to Northstar Mezzanine Partners V L.P., a Delaware limited partnership, as administrative agent and purchaser ("Northstar"), in and to certain intellectual property of the Grantor, including without limitation (a) the trademarks identified on Exhibit A attached hereto (the "Trademarks") and such Agreement was recorded with the United States Patent and Trademark Office on December 11, 2012 at Reel/Frame 4916/0655 (Global Parts Distributors, LLC) and Reel/Frame 4916/0705 (Santech Industries, LLC); and (b) the Patents identified on Exhibit B attached hereto (the "Patents" – hereinafter the Trademarks and the Patents may be referred to collectively as the "Intellectual Property") and such Agreement was recorded with the United States Patent and Trademark Office on December 11, 2012 at Reel/Frame: 029444/0475.

WHEREAS, the obligations of the Grantors underlying the Agreement have been satisfied and terminated.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, for itself and as agent for and on behalf of the lenders, hereby releases and terminates its security interests and any other right, title or interest it may have in the intellectual property, together with the right to recover for any past infringements thereof, effective as of the date set forth below and does hereby agree to the filing of this termination and release in the United States Patent and Trademark Office.





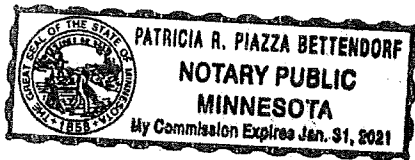
