**RELEASE OF SECURITY INTEREST IN TRADEMARKS (FIRST LIEN)**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of September 9, 2016 (“Effective Date”), by DEUTSCHE BANK TRUST COMPANY AMERICAS, as collateral agent for the benefit of the Secured Parties (“Collateral Agent”), in favor of CANNERY CASINO RESORTS, LLC, a Nevada limited liability company (“CCR Pledgor”), and WASHINGTON TROTTHING ASSOCIATION, LLC (fka Washington Trotting Association, Inc., as successor in interest to CCR Pledgor), a Delaware limited liability company (“WTA Pledgor”).

**WHEREAS**, Collateral Agent, CCR Pledgor, WTA Pledgor and certain other pledgors referred to therein are party to that certain First Lien Security Agreement dated as of October 2, 2012 (as amended, restated, amended and restated, supplemented, restructured, or otherwise modified from time to time, the “First Lien Security Agreement”);

**WHEREAS**, pursuant to the terms and conditions of the First Lien Security Agreement, CCR Pledgor entered into that certain Trademark Security Agreement dated as of October 2, 2012 (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the “First Lien Trademark Security Agreement”) in favor of Collateral Agent;

**WHEREAS**, pursuant to the terms and conditions of each of the First Lien Security Agreement and the First Lien Trademark Security Agreement, CCR Pledgor granted to Collateral Agent a security interest and lien in and to all of the United States Trademark registrations set forth on Schedule A attached hereto and all Proceeds of the foregoing (collectively, the “Released Trademark Collateral”);

**WHEREAS**, the First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 3, 2012 at Reel/Frame No. 4871/0792;

**WHEREAS**, effective September 1, 2016, CCR Pledgor sold, conveyed, transferred and assigned all right, title and interest in and to the Released Trademark Collateral to WTA Pledgor, such that WTA Pledgor is the current owner of the Released Trademark Collateral; and

**WHEREAS**, pursuant to the terms and conditions of each of the First Lien Security Agreement, WTA Pledgor granted to Collateral Agent a security interest and lien in and to all of its assets, whether then existing or thereafter arising or acquired from time to time;

**WHEREAS**, Collateral Agent has agreed to terminate and release its security interest and lien in and to the Trademark Collateral and to reconvey any and all rights in the Released Trademark Collateral to the WTA Pledgor.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, effective as of the date hereof, Collateral Agent hereby (i) terminates and releases any and all security interests and liens it has against the Released Trademark Collateral, whether under the First Lien Security Agreement or the First Lien Trademark Security Agreement, (ii) releases the Released Trademark Collateral from the First Lien Security Agreement and the First Lien Trademark Security Agreement and (iii) reconveys and assigns to WTA Pledgor all of Collateral Agent’s right, title and interest (if any) in and to the Released Trademark Collateral. This Release is applicable only and relates solely to the Released Trademark Collateral and no other collateral under the First Lien Security Agreement or the First Lien Trademark Security Agreement.




