TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made effective as of August 1, 2016 ("Effective Date"), by and between DOMINION ENTERPRISES ("Assignor"), a Virginia general partnership, and DOMINION MARINE MEDIA, LLC ("Assignee"), a Virginia limited liability company.

WHEREAS, Assignor owns all right, title, and interest in and to the trademarks listed in Exhibit A hereto; and

WHEREAS, Assignor wishes to assign to Assignee the trademarks listed in Exhibit A hereto and certain related rights, and Assignee wishes to accept such assignment;

NOW, THEREFORE, in return for good and valuable consideration exchanged between Assignor and Assignee, the receipt and adequacy of which each of them acknowledges, the parties do hereby agree as follows:

1. Assignment. Assignor hereby assigns to Assignee, and Assignee hereby accepts, all of Assignor's right, title, and interest in and to the trademarks listed in Exhibit A (collectively, "Trademarks"), including without limitation the United States Patent and Trademark Office and European Union Intellectual Property Office registrations, applications, renewals, and/or extensions of protection therefor; all application, registration, maintenance, and renewal rights with respect to the Trademarks; all common law or similar rights with respect to the Trademarks; all rights to create new marks based on the Trademarks; all the goodwill of that business that deals in any or all of the goods and/or services with which any or all of Trademarks has/have been used or is/are used, in association therewith; and any and all actions and rights of action for infringement, violation, or misappropriation, including without limitation the right to sue and collect damages for past, present, and future infringement, violation, or dilution, of the foregoing right, title, and interest in and to the Trademarks and/or otherwise with respect to the Trademarks, whether arising before, on, or after the Effective Date, including all income, royalties, damages, claims, and payments now or hereafter due or payable under or with respect to the foregoing; and all rights corresponding to any of the foregoing throughout the world (collectively, the "Trademark Rights"), in the case of all of the foregoing, to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives, to be used as fully and entirely as said rights would have been held and enjoyed by Assignor had this Assignment not been made.

2. Assistance. At any time and from time to time, at Assignee's reasonable request and expense, Assignor agrees to execute further documents and instruments and to do such other acts as may be necessary or reasonably requested by Assignee to more effectively vest full title in and to the Trademark Rights or to evidence assignment of the same to Assignee.

3. Governing Law. This Assignment will be construed in accordance with, and any and all actions arising hereunder will be governed by, the laws of Commonwealth of Virginia without regard to its choice-of-law rules and, to the extent, if any, applicable, the trademark laws of the United States or the European Union.

4. Execution. This Assignment may be executed in counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument. Signatures hereon delivered by facsimile or in .pdf or other electronic files will be deemed as binding as original signatures.


