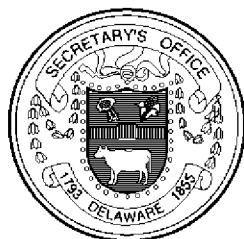

**FOURTH:** The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.


**FIFTH:** The merger is to become effective on November 19, 2010 (for accounting purposes only).
