ASSIGNMENT

This agreement, effective this 1st day of April, 2016 ("Effective Date") is by and between Boston Cedar, Inc. a Massachusetts corporation having a place of business at 80 Hampden Road, Mansfield, MA 02148 (hereinafter "Assignor") and U.S. Lumber Group, LLC, a Delaware limited liability company, having a place of business at 2160 Satellite Blvd., Suite 450, Duluth, GA 30097 (hereinafter "Assignee").

WHEREAS, Assignor is the owner of all right, title and interest in and to the trademark listed on Schedule A attached hereto and incorporated herein (hereinafter the "Mark") and the goodwill associated therewith;

WHEREAS, Assignee is desirous of owning all right, title and interest in and to the Marks and the goodwill associated therewith;

NOW THEREFORE in pursuant to that certain Asset Purchase Agreement dated April 1, 2016 by and among the Assignor, Assignee and Robert F. Arkner and in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby mutually acknowledged, the parties agree as follows:


Assignor hereby unconditionally and irrevocably conveys, transfers and assigns to Assignee, and Assignee accepts, all of Assignor's right, title and interest in and to the following with respect to the Mark: (i) the trademark registrations, trademark applications common law rights and goodwill in and to the Mark and all issuances, extensions and renewals thereof; (ii) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by the applicable law of any jurisdiction, by international treaties and conventions and otherwise


throughout the world; (ii) any and all royalties, fees, income, payments and other proceeds not or hereafter due or payable with respect to any and all of the foregoing; and (iv) any and all claims and causes of action, whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect or otherwise recover any such damages, with respect to any of the foregoing.
