NOTICE OF RELEASE OF SECURITY INTEREST

This Notice of Release of Security Interest (the "Release") is effective as of September 8, 2016, by **CERBERUS BUSINESS FINANCE, LLC**, in its capacity as collateral agent for itself and the other Secured Parties (together with its successors, "Agent").

WHEREAS, reference is made to that certain Grant of a Security Interest – Trademarks (the "Trademark Security Agreement") dated as of November 9, 2011 by **AMERIMARK DIRECT LLC**, a Delaware limited liability company, and **DR. LEONARD'S HEALTHCARE CORP.**, a Delaware corporation (collectively, the "Grantors", and each individually a "Grantor"), in favor of Agent; and

WHEREAS, pursuant to the Pledge and Security Agreement (as defined in the Trademark Security Agreement), the Grantors granted to Agent a continuing security interest in all right, title and interest of the Grantors in, to and under the trademarks and service marks listed on the attached Schedule A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks") together with, among other things, the goodwill of the business symbolized by the Trademarks and applications thereof and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral") owned by the Grantors as described in the Trademark Security Agreement to secure the payment, performance and observance of the Secured Obligations; and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 11, 2011 at Reel/Frame 4659/0608.


NOW, THEREFORE, intending to be legally bound hereby and in connection with the Trademark Security Agreement, Agent hereby releases and remits, without any recourse, representation or warranty, any and all rights, title and interests in and to the Collateral, and hereby authorizes the Grantors or the Grantors' authorized representative to record this Release with the United States Patent and Trademark Office as evidence of such release. Agent further agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantors may reasonably require to effect the intent and purpose of this Release, provided that all such documents shall be prepared by the Grantors' counsel and the cost and expense of such documents and actions shall be borne solely by the Grantors.

All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
