RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated September 9, 2016 by BANK OF MONTREAL, as Agent ("*BMO*"), with its mailing address at 115 South LaSalle Street, Chicago, Illinois 60603, acting as administrative agent hereunder for the Secured Creditors as defined in the Agreement referred to below (BMO acting as such administrative agent being hereinafter referred to as the "*Agent*");

WITNESSETH:

WHEREAS, CRST Malone, Inc., a Delaware corporation ("*Debtor*") with its principal place of business and mailing address at 1901 Floyd Bradford, Trussville, Alabama 35173 and Agent were parties to a certain Trademark Security Agreement dated June 29, 2012 between Debtor and Agent which was recorded in the United States Patent and Trademark Office on July 3, 2012 at Reel 004814, Frame 0110 (the "*Agreement*"), pursuant to which Debtor granted to Agent, a security interest in, among other things, trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademark Property*"); and

(ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.
