THIS ASSIGNMENT is made the 14th day of September, 2016, by and between Kabbage, Inc. WHEREAS, Assignor is the registrant for U.S. Trademark Registration No. 3,905,311 for KABBAGE and, (hereinafter, the "Mark");




