TRADEMARK SECURITY RELEASE

THIS TRADEMARK SECURITY RELEASE (this "Release") is made as of September 12, 2016, by FIFTH STREET FINANCE CORP., a Delaware corporation (the "Administrative Agent"), as administrative agent for the secured parties under the Credit Agreement referred to below (the "Secured Parties"), in favor of (i) ONCOURSE LEARNING CORPORATION, a Delaware corporation and the successor-in-interest to ADVANCED EDUCATION SYSTEMS, LLC, a Maryland limited liability company, COMPLIANCE MANAGEMENT SERVICES, LLC, a Maryland limited liability company, CORPORATE TRAINING TECHNOLOGIES, LLC, a Delaware limited liability company, DIGITAL UNIVERSITY, INC., a California corporation, and GHG ACQUISITION, INC., a Delaware corporation (the "Lead Borrower"), (ii) ONCOURSE REAL ESTATE, INC. (f/k/a AMERICAN HOME INSPECTORS TRAINING INSTITUTE, LTD.), a Wisconsin corporation and the successor-in-interest to PROSCHOOLS ACQUISITION COMPANY, a Delaware corporation, PROSCHOOLS, INC., an Oregon corporation, and KEEN SKILLS, INC., a Florida corporation ("ORL"), (iii) CIP OCL HOLDINGS, INC., a Delaware corporation ("CIP Holdings"), and (iv) CIP OCL ACQUISITION, INC., a Delaware corporation (jointly and severally, individually and collectively with the Lead Borrower, ORL and CIP Holdings, the "Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Credit Agreement, dated as of February 28, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Administrative Agent, each party listed on the signature pages thereof as a borrower thereunder, and the lenders from time to time party thereto, Grantor executed and delivered to the Administrative Agent (i) that certain Pledge and Security Agreement, dated as of February 28, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Master Security Agreement"), (ii) that certain Trademark Security Agreement, dated as of February 28, 2014 (the "Original TSA"), (iii) that certain Annex to Trademark Security Agreement, dated as of December 29, 2014 (the "Annex"), and (iv) that certain Amended and Restated Trademark Security Agreement, dated as of March 8, 2016 (the "A&R TSA"), and together with the Master Security Agreement, the Original TSA and the Annex, the "Security Agreements");

WHEREAS, pursuant to the Security Agreements, Grantor pledged and granted to the Administrative Agent for the benefit of the Secured Parties a security interest in and to all of the right, title and interest of Grantor in, to and under the Trademark Collateral (as used herein, such term shall have the meanings given to such term in the Original TSA, including the Annex thereto, and the A&R TSA) including, among other things, the Trademark registrations and Trademark applications set forth on Exhibit A attached hereto;

WHEREAS, the Original TSA was recorded with the United States Patent and Trademark Office ("USPTO") on March 5, 2014 at Reel 5230, Frame 905, the Annex was recorded with the USPTO on January 15, 2015 at Reel 5442, Frame 151, and the A&R TSA was recorded with the USPTO on March 31, 2016 at Reel 5762, Frame 732;

WHEREAS, Grantor has requested that Administrative Agent release its security interest in the Trademark Collateral, and Administrative Agent has agreed to terminate and release the entirety of its security interest in and to the Trademark Collateral; and

WHEREAS, Grantor has requested, and the Administrative Agent has agreed, to provide a document suitable for recording with the USPTO evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby states as follows:

1. Administrative Agent, on behalf of itself and the Secured Parties, hereby terminates, cancels and releases its security interest in all of Grantor's right, title and interest in and to the Trademark Collateral.

2. Administrative Agent hereby releases and reassigns to Grantor, without any warranty, representation, recourse or undertaking by Administrative Agent, any and all of Administrative Agent's right, title and interest that it may have obtained in and to the Trademark Collateral pursuant to the Security Agreements and does hereby authorize Grantor (personally or through its designees and at Grantor's sole expense) to take all actions reasonably necessary to release and terminate any and all security interests and other liens in the Trademark Collateral, including submitting this Release to the USPTO. Administrative Agent authorizes and requests that the USPTO note and record the existence of the release hereby given. If and to the extent Administrative Agent has acquired any right, title or interest to any of the Trademarks or the goodwill associated therewith, it hereby assigns and transfers such right, title or interest to Grantor.

3. Administrative Agent agrees, at Grantor's sole cost and expense, to take all further actions, reasonably acceptable to Administrative Agent, and to provide to Grantor and each of its successors, assigns or other legal representatives, all such cooperation and assistance, including, without limitation, the execution and delivery of any and all documents or other instruments, as Grantor may reasonably request, in order to confirm, effectuate or record this Release.




