TRADEMARK ASSIGNMENT

WHEREAS, Frank's Casing Crew & Rental Tools, Inc., a Louisiana corporation located at 700 E. Verot School Road, Lafayette, Louisiana, 70508, (hereinafter "said Assignor"), commenced using, in its business, the mark "TAWG" (hereinafter "said Trademark") and said Assignor was granted United States Trademark Registration No. 3,666,096 dated August 11, 2009 which issued with respect to both International Class 007 goods and International Class 037 services (hereinafter "said Registration");

NOW, THEREFORE, in consideration of and in exchange for the sum of ten dollars (\$10.00), and other good and valuable consideration, the receipt of which is hereby acknowledged, said Assignor does sell, assign, transfer and set over to said Assignee the entire right, title, and interest in and to said Trademark, and said Registration, and the goodwill of the business in which said Trademark is used or with that part of the goodwill of the business connected with the use of and symbolized by said Trademark, and said Assignor also hereby transfers said Registration as well as the original Certificate of Registration of said Trademark to said Assignee.

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment;

ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said Trademark as may be known and accessible to ASSIGNOR and will testify, at Assignee's cost including reasonable compensation for Assignor's employees and representatives, as to the same in any litigation or proceeding related thereto and will promptly execute and deliver to ASSIGNEE, or its legal representatives, any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said Registration.

This Assignment contains the entire and only understanding between the parties hereto respecting the subject matter hereof, and any warranty, representation, promise or condition, not incorporated herein, shall not be binding upon either party.
