**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of September 12, 2016 (this "Release"), is made by **COVERIS ADVANCED COATINGS US LLC** ("Grantor"), as follows. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Credit Agreement and Trademark Security Agreement dated November 8, 2013.

**WITNESSETH**

WHEREAS, pursuant to the Trademark Security Agreement, dated as of November 8, 2013, and recorded with the U.S. Patent and Trademark Office on November 15, 2013, at Reel/Frame No. 5154/09184 and with the Canadian Intellectual Property Office on November 15, 2013 (the "Trademark Security Agreement"), Grantor granted to the Collateral Agent a security interest in and continuing lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States and Canadian trademarks set forth on Schedule A attached hereto (the "Released Registered Trademarks"); and

WHEREAS, Grantor has requested that the Collateral Agent release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Trademark Collateral, including the Released Registered Trademarks; and

WHEREAS, the Collateral Agent now desires to terminate and release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Trademark Collateral, including the Released Registered Trademarks, and reassign any all rights, title and interest in the same to Grantor.


NOW, THEREFORE, the Collateral Agent, without recourse, representation or warranty of any kind or nature, and at Grantor's sole cost and expense, hereby terminates, cancels and releases its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Trademark Collateral, including the Released Registered Trademarks, and any and right, title and interest of the Collateral Agent in such Trademark Collateral and such Released Registered Trademarks, including all goodwill associated therewith, is hereby assigned, transferred, and conveyed to Grantor.

The Collateral Agent authorizes and requests that the Commissioner of Patents and Trademarks, the Canadian Intellectual Property Office and any other applicable government officer record this Release.
