**RELEASE AND DISCHARGE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

RECITALS:

- A. Pursuant to the terms and conditions of certain security documents, including a second lien intellectual property security agreement and a debenture (as amended, amended and restated, replaced, supplemented, or otherwise modified, the "**Security Agreements**") each dated as of October 16, 2012 and entered by Q9 Networks Inc. (the "**Grantor**") in favour of Ares Capital Corporation (successor to Barclays Bank PLC), as administrative agent for and on behalf of certain Secured Parties (as defined therein) (the "**Administrative Agent**"), the Grantor has granted and pledged in favour of the Administrative Agent, for the benefit of the Secured Parties, *inter alia*, a security interest in all of the Grantor's right, title and interest in and to trademarks owned by Grantor (collectively, the "**Trademarks**"), including, without limitation, the United States and Canadian trademark registrations set forth on Schedule A attached hereto.
- B. Notice of the Administrative Agent's security interest in the Trademarks was recorded by the Canadian Intellectual Property Office ("**CIPO**") and the United States Patent and Trademark Office ("**USPTO**") on the dates specified in Schedule A annexed hereto.
- C. The Grantor has requested that the Administrative Agent (i) execute and deliver this release and discharge of all of the Administrative Agent's right, title and interest in and to the Trademarks, and (i) register such release and discharge with CIPO and USPTO.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. **Defined Terms.** Capitalized terms used in this release and discharge and not otherwise defined shall have the respective meanings attributed to them in the Security Agreements.
2. **Release and Discharge of Security.** The Administrative Agent, for and on behalf of the Secured Parties, hereby irrevocably releases, remises and forever discharges any and all interests it has against the Trademarks.
3. **Governing Law.** This release and discharge shall be governed by, and interpreted and enforced in accordance, with the laws of the Province of Ontario and the federal laws of Canada applicable in the Province of Ontario.
