This Release of Security Interest in Trademarks (this "Release") may be filed with the United States Patent and Trademark Office to evidence Secured Party's release of its security interest against such trademarks, trademark registrations and trademark applications.

This Release is intended to operate as a release of all liens and security interests conveyed by Grantor to Secured Party pursuant to the terms of the Trademark Agreement, without any representation, warranty or undertaking by, or recourse to, Secured Party. If and to the extent Secured Party has acquired any right, title or interest in or to any of the Trademark Collateral pursuant to the terms of the Trademark Agreement, Secured Party hereby reassigns and transfers such right, title and interest to Grantor, without any representation, warranty or undertaking by, or recourse to, Secured Party.
