## **NOTICE OF TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Notice of Termination and Release of Intellectual Property Security Agreement (this "Release") is made and effective as of September 5, 2016 and is filed by Novati Technologies, Inc., a Texas corporation (hereinafter referred to as "Grantor") to provide notice of the release of a security interest held by Silicon Valley Bank, a California corporation (hereinafter referred to as "Bank") in intellectual property held by Grantor.

1. Pursuant to the terms of that certain Loan and Security Agreement dated September 26, 2014, and that certain Intellectual Property Security Agreement dated September 26, 2014 (collectively hereinafter referred to as the "Security Agreement"), Grantor granted and pledged to Bank, a security interest in all of Grantor's right, title and interest in, to and under its intellectual property (all of which collectively is referred to as the "Intellectual Property Collateral"), to secure the payment, performance and observance of obligations.

2. The Intellectual Property Security Agreement was made of record in the United States Patent and Trademark Office ("USPTO") on October 6, 2014 at Reel/Frame 005376/0235.

3. Grantor has agreed to execute and deliver to Bank this Notice for purposes of filing the same with the USPTO to verify, confirm and evidence the termination, discharge and release of the security interest in the Intellectual Property Collateral, granted pursuant to the Security Agreement, including, without limitation, the following :

(a) Any and all copyright rights, copyright applications, copyright registrations and like protections in each work or authorship and derivative work thereof, whether published or unpublished and whether or not the same also constitutes a trade secret, now or hereafter existing, created, acquired or held, including without limitation those set forth on Exhibit A attached hereto (collectively, the "Copyrights");

(b) Any and all trade secrets, and any and all intellectual property rights in computer software and computer software products now or hereafter existing, created, acquired or held;

(c) Any and all design rights that may be available to Grantor now or hereafter existing, created, acquired or held;

(d) All patents, patent applications and like protections including, without limitation, improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same, including without limitation the patents and patent applications set forth on Exhibit B attached hereto (collectively, the "Patents");

(e) Any trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of

the business of Grantor connected with and symbolized by such trademarks, including without limitation those set forth on Exhibit C attached hereto (collectively, the "Trademarks");

(f) All mask works or similar rights available for the protection of semiconductor chips, now owned or hereafter acquired, including, without limitation those set forth on Exhibit D attached hereto (collectively, the "Mask Works");

(g) Any and all claims for damages by way of past, present and future infringements of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights identified above;

(h) All licenses or other rights to use any of the Copyrights, Patents, Trademarks, or Mask Works and all license fees and royalties arising from such use to the extent permitted by such license or rights;

(i) All amendments, extensions, renewals and extensions of any of the Copyrights, Trademarks, Patents, or Mask Works; and

(j) All proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.

4. This Release constitutes public notice of the termination, discharge and release of Bank's security interest in and lien on Grantor's right, title and interest in, to and under the Intellectual Property Collateral.

5. Grantor hereby requests the USPTO to file and record the same together with the attached exhibits.

6. Grantor and Bank hereby acknowledge and agree that the security interest in the Intellectual Property Collateral has been terminated in accordance with the terms of the Security Agreement.


