## CONFIRMATORY INTELLECTUAL PROPERTY SECURITY AGREEMENT

**THIS CONFIRMATORY INTELLECTUAL PROPERTY SECURITY AGREEMENT** (the **Agreement**) is made between Q9 Networks Inc., Q9 Holdings Inc., Q9 Networks Fibre Holdings Inc., Q9 Networks Pacific Holdings Inc. and Q9 Networks Property Holdings Inc. (each a "**Debtor**" and collectively, the "**Debtors**") and Bell Canada (the, "**Creditor**"), with its address at 1, carrefour Alexander-Graham-Bell, Tour A, 8ieme étage, Verdun, Québec H3E 3B3 CANADA.

**WHEREAS** the Debtors and the Creditor are parties to a General Security Agreement dated September 16 2016 (as the same may be amended, modified, supplemented, renewed, extended or restated from time to time, the "**GSA**") pursuant to which the Debtors granted to the Creditor, *inter alia*, a security interest in, and lien upon all Intellectual Property Rights (as defined in the GSA).

**NOW, THEREFORE**, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the Parties, the Debtors confirms that it has granted, and for greater certainty hereby grants, to Creditor a continuing security interest in all of Debtors' right, title and interest in and to Debtors' Intellectual Property Rights, including the trade-marks, trade-mark registrations and trade-mark applications referred to in Schedule 1 annexed hereto.

All capitalized terms used herein but not otherwise defined shall have the meanings set forth in the GSA. This Agreement may be executed in any number of counterparts (including by way of facsimile or electronic transmission) and all or such counterparts taken together shall be deemed to constitute one and the same instrument.

This Agreement shall be governed by and interpreted and enforced in accordance with the laws of the Province of Ontario and the laws of Canada applicable therein.


