This ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS (this "Assignment"), dated as of August 15, 2016, is by GENERAL ELECTRIC COMPANY (individually, "GE"), successor by merger to General Electric Capital Corporation, a New York corporation, acting in its capacity as the retired administrative agent and the retired collateral agent (in each such capacity, the "Retired Agent") and WELLS FARGO BANK, N.A., (individually, "Wells Fargo"), acting in its capacity as the successor administrative agent and the successor collateral agent (in each such capacity, the "Successor Agent").

**RECITALS:**

WHEREAS, SPTC, Inc., as "Grantor", and Retired Agent are parties to those certain intellectual property security agreements identified in Exhibit A attached hereto (as the same have been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, collectively, the "Agreements") covering certain intellectual property, including those set forth on Exhibit B attached hereto; and

WHEREAS, pursuant to that certain Resignation and Agency Substitution Agreement by and among, inter alia, GE, as the Retired Agent, and Wells Fargo, as Successor Agent, Retired Agent has assigned to Successor Agent all of its rights, remedies, duties and other obligations under, among other documents, the Agreements, in each instance, in its capacity as collateral agent.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Retired Agent hereby assigns and transfers to Successor Agent and its successors and assigns, all of its rights, title and interest in and to the Agreements.

This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed an original and all of which taken together shall constitute one and the same instrument.
